# **DESCRIPTION OF TOWN APPOINTED BOARDS & COMMITTEES**

### **PLANNING BOARD**

Prepares and submits zoning ordinances and maps to the Town Board for consideration and possible adoption. The Planning Board may initiate from time to time, proposals for amendment of zoning ordinances, based upon its studies and comprehensive plan.

Term: 3 years

Members: 9 (4 members must reside within and represent the Haywood County side of the Rough Creek Watershed Extrater-ritorial Jurisdiction (ETJ), Pigeon River Watershed ETJ, Old Asheville Highway ETJ, and the Buncombe County side of the Rough Creek Watershed)

#### **ZONING BOARD OF ADJUSTMENT**

Hears hardship cases when a property owner is requesting a variance or is appealing a decision made by the Town's Planning Department. This board makes the final decision on the case being heard and is not heard by the Town's Aldermen/women.

Term: 3 years

Members: 9 (4 members must reside within and represent the Haywood County side of the Rough Creek Watershed Extrater-ritorial Jurisdiction (ETJ), Pigeon River Watershed ETJ, Old Asheville Highway ETJ, and the Buncombe County side of the Rough Creek Watershed)
